

# OUTSTANDING DEAF SPORTSMAN / SPORTSWOMAN Nomination Form



## ABOUT THE AWARD

The Outstanding Deaf Sportsman/Sportswoman Awards are conferred annually by The Singapore Association for the Deaf (SADeaf) to recognise the achievements of the Deaf\* individuals in the sports arena.

\* Deaf refers to person with different degree of hearing loss.

## ELIGIBILITY

1. The nominees must be Registered Clients of SADeaf
2. The nominees must have outstanding track record(s) in sports this year. These can be evidenced by awards obtained, records of activities denoting leadership qualities or good sportsmanship.
3. **Only one "Outstanding Deaf Sportsman Award" and one "Outstanding Deaf Sportswoman Award" will be conferred each year.**

## NOMINATION PROCEDURES

1. Nominations can be made by anyone (**self-nomination is not eligible**) but must be supported by one of the following:
  - The schools
  - Singapore Disability Sports Council
2. Nominations must be submitted by 15 June 2017. **Late submissions will not be entertained.**
3. Nominations can be made on photocopied forms.

## SELECTION

The nominations will be reviewed by independent Award Vetting Panel comprising representatives from SADeaf, the Deaf Community, reputable organisations in Singapore and ex-awardees. Recommendations of the Award Vetting Panel will be submitted to the Executive Council of SADeaf for approval. Once officially approved, it will be deemed final and no further objections will be entertained.

Shortlisted nominees may be required to attend an interview.

## PRIZES

A \$500 cash voucher, a plaque and a certificate will be presented to the winners at an Award Presentation ceremony.

## PRESENTATION OF AWARD

Winners of the Award will be notified in writing by SADeaf latest by 19 August 2017. Awards will either be presented at the International Week of the Deaf celebration or any other appropriate occasion in the year of 2017.
