

I-L-Y (I LOVE YOU) AWARD Nomination Form



ABOUT THE AWARD

The I-L-Y Award is given to an **individual** (a registered volunteer of The Singapore Association for the Deaf (SADeaf)) or organisation or a group (an **organisation** or a **group** registered under the corresponding Act of Singapore, the size of which should not be less than 3 persons) or any Multi-National Corporation who is not registered or based in Singapore, that has made efforts in providing social, educational or financial contributions to the Deaf Community in the last financial year for this whole year.

This I-L-Y Award is divided into 3 tiers:-

- Diamond I-L-Y Award
- Ruby I-L-Y Award
- Sapphire I-L-Y Award

CRITERIA FOR NOMINATIONS

Diamond I-L-Y Award

This will be awarded to those who meet one of the following criteria:

1. An organisation or a group which has contributed a minimum of 10,000 hours of service per year.
2. An individual who has contributed a minimum of 400 hours per year.
3. Those who have donated \$100,000 or above either in cash or in kind to support any of SADeaf's programmes.

Ruby I-L-Y Award

This will be awarded to those who meet one of the following criteria:

1. An organisation or a group which has contributed a minimum of 5,000 hours of service per year.
2. An individual who has contributed a minimum of 200 hours per year.
3. Those who have donated \$50,000 or above in cash or in kind to support any SADeaf's programmes.

Sapphire I-L-Y Award

This will be awarded to those who meet one of the following criteria:

1. An organisation or a group which has contributed a minimum of 1,000 hours of service per year.
2. An individual who has contributed a minimum of 100 hours per year.
3. Those who have donated \$10,000 or above in cash or in kind to support any SADeaf's programmes.

NOMINATION PROCEDURES

1. Nominations must be made on the appropriate form, put in a sealed envelope and dispatched either by hand or mail to:

on/before the closing date by 15 June 2017. Late submissions will not be entertained.

2. Nominations can be made by any Member/Registered Client of SADeaf (**self-nomination is not eligible**) but must be supported by one of the following SADeaf Committees, viz;
 - Administration and Finance Committee
 - Community Services Committee
 - Deaf Access Committee
 - School Management Committee – Singapore School for the Deaf
 - School Management Committee – Mountbatten Vocational School
3. The nominations will be reviewed by independent Award Vetting Panel which comprises the following:-
 - A Chairman (an Executive Council member of the SADeaf)
 - 2 deaf members from SADeaf
 - An ex-awardee
 - Representatives from **reputable** organisations in Singapore
4. Recommendations of the Award Vetting Panel will be submitted to the Executive Council of SADeaf for approval. Once officially approved, it will be deemed final and no further objections will be entertained.

PRESENTATION OF AWARD

Winners of the Awards will be notified in writing by SADeaf latest by 19 August 2017. Awards will either be presented at the International Week of the Deaf celebration or any other appropriate occasion in the year of 2017.
