



CORRIGENDUM TO THE ANNUAL REPORT FOR FINANCIAL YEAR 2019/2020

The Singapore Association for the Deaf (“SADeaf”) refers to the SADeaf Annual Report 2019/2020 for the financial year ended 31 March 2020. SADeaf wishes to inform members that:

- On page 7, under the “Output Indicator – Basic Programme Data” section, for the pie chart titled FY2019/2020, the unique clients’ (red) portion reads 130, while the breakdown (comprising Financial Assistance, Employment, Housing, Counselling, Other Case Management) adds up to 132 in total. This is to clarify that 130 refers to the number of unique clients, while 132 refers to the number of issues faced by clients. Some clients had presented more than one issue for their cases.
- On page 40, for “Enrolment” table:
Under the “Multiple” column, “ISC Food & Beverage Service” should be 1% instead of 2%.
Under the “Multiple” column, “Total” should be 1% instead of 2%.
Under the “Total” column, “ISC Food & Beverage Service” should be 19% instead of 18%.
Under the “ISC Housekeeping Operations” row, the “NA” column should be 1% instead of 2%, and the “Total (%)” column should be 1% instead of 2%.

The above changes (in red) are reflected in the table below.
